## Policy on Privacy and Cookies

Fundo Sete Colinas wishes to guarantee and protect the privacy of all the data provided by the user and to comply with its obligations under the Law on the Protection of Personal Data. Our Policy on Privacy and Cookies defines how any personal information provided to us is processed when you use this site.

**Policy on the Use of Cookies** Fundo Sete Colinas uses cookie technology on this site. Because user consent is necessary, Fundo Sete Colinas will only use cookies if you have agreed to their use.

Cookies are small information files that identify your computer on our server, only retaining information related to your preferences. The cookies used by Fundo Sete Colinas do not identify the user and are not used to gather personal data.

There are various kinds of cookies, having different characteristics and functions. These are:

- Essential (session) cookies – They are very important for access to specific areas of the site and to allow proper navigation.
- Functional (persistent) cookies – Functional cookies enable user preferences to be stored when visiting the site. In this way, it is not necessary to personalise the site every time you visit it.
- Analytical cookies – This type of cookie makes it possible to analyse the way users use the site and to find out which pages are the most popular and monitor the performance of the site, learning about any error messages on the site. Information of a personal nature will never be revealed.

The user may, at any time, configure his computer to accept all cookies, notify him when a cookie is issued or reject all cookies. Refusing the use of cookies on the site may result in not being able to access some of the areas of the site or in not being able to receive personalised information.
